



GENERAL INFORMATION - The Frazer real estate is located at 2001 Main, Warsaw, IL which is on the Warsaw Road ½ mile east of Warsaw or from Hamilton, IL 3 miles southwest to the junction of Highway 96 and Warsaw Road then 2 miles west. Prospective buyers have permission to inspect Tract 1, however, for a personal inspection of the house and all buildings on Tract 2, please contact an Auction Representative.

TRACT 1 - 64 acres (subject to survey) located in Sections 3 and 10 of Warsaw Township, Hancock County, Illinois. It contains approximately 30 acres of level to rolling tillable farm land, 10 acres of pasture and 24 acres of rolling hardwood timber. The south end of this tract borders Tract 2 and also the Warsaw Road. The north end borders the DNR Alice Kibbe Wildlife Nature Preserve. This tract sells with immediate possession including 2018 farming and hunting rights.

TRACT 2 - 3 acres (subject to survey) located at the southwest corner of Tract 1 and borders the Warsaw Road on the south. Improvement include a 1½ story home, an open front machine shed, a machine shed/barn and a garage. The house features 3 bedrooms (2 upstairs and 1 down), kitchen, dining room and bath. There is a basement accessible from the outside. This property is serviced by City water and natural gas. 
