
LOCATION & GENERAL INFORMATION

This 43 acre farm is secluded and privately located at the end of a hard surfaced public road. There are 16 level tillable acres currently being used for grass hay. Much of the balance is rolling timber with an abundance of deer, turkey and small game. There is also a one-acre pond. An older set of improvements include a home in need of repair, a Morton machine shed in average condition, 3 smaller grain bins (approx. 3,000 bu. ea.), one with dryer, and several older barns and sheds.

If you're looking for a beautiful home building site or just a recreational property to enjoy on weekends, this one has a lot to offer. It's only a short distance from Macomb, IL and 1 mile west of Argyle Lake State Park. West Prairie Water is on the property along with a well.

Prospective buyers have permission to inspect the farm by walking or ATV. Please stay out of buildings (cameras are up).
